o Property taxes, for the 2020 tax year, will be due as normal with a 60-day grace period for late payment penalties per a recent Cook county ordinance.

■ First installment was due – March 2, 2021

■ Late payment charges begin to accrue – May 3, 2021

· **Principle, Interest, Taxes, Insurance and Energy (PITIE) Review:** NHS now offers free reviews of your monthly/annual spend on electric, gas, water and insurance. During the review, we also review your property tax history to identify any missed exemptions or refunds owed to you. This review can serve as a great tool to identify funds to help meet your current property tax obligations and stretch your monthly budget.
