JANUARY MEETING RECAP: ROAD CLOSURE UPDATE

According to a representative from Metra who joined us at our January meeting, full closure of 87th Street from Dauphin Avenue to Dobson Avenue started on January 6, 2025, through July 2025(NEW DATE), for Metra station construction. Detour Eastbound 87th Street to Southbound Cottage Grove Avenue, to Eastbound 95th Street, to Northbound Stony Island Avenue, and back to Eastbound 87th Street. Reverse for Westbound 87th Street traffic.

CCC Special note: If you decide to reroute to 83rd Street, beware of speed traffic devices on 83rd Street near Avalon Park.

ADDITIONAL JANUARY MEET-ING FOLLOW-UP REGARDING TRANSPORTATION

According to Deputy Commissioner Alonzo Owens, Chicago Department of Transportation:

- a. 87th State to Lafayette congestion issue. Division of Electrical Operations (DEO) reset the controller on January 15.
- b. The Viaduct at 91st and King Drive and 91st Indiana has new lights. The potholes under both viaducts were addressed. Deputy Commissioner Owens will speak to the Alderpersons regarding power washed, painting, and holes patched in the wall.
- c. Metra Station Detour- The community recommended that the detour at 87th -89th Greenwood is a two-way street and consideration to make it no parking on one side during the construction to help with traffic congestion. Stay tune for updates
- d. The Viaduct at 71st and Cottage Grove and 73rd Street east of Cottage Grove will fully reopen by 7/1/2025
