2019 SHARED COST SIDEWALK PROGRAM

The city of Chicago has begun the "Shared Cost Sidewalk Program" (formerly the 50/50 sidewalk program). Applications will be taken on a first-come, first-served basis. The number of participants is based on availability of funds. The program typically reaches capacity quickly, so you are encouraged to apply early. Please note that if you applied for the program in previous years, you must apply again in 2019 if you wish to be considered for the 2019 program. Applications will only be accepted through the City's 311 system by calling 311 or through the City's service request website 311.chicago.gov. The property owner's contact information and the property address are required at the time of request.

\$8.3 MILLION IN COOK COUNTY PROPERTY TAX REFUNDS TO BE ISSUSED AUTOMATICALLY

More than \$8 million in property tax refunds will be sent over the next few weeks to nearly 30,000 Cook County homeowners who have overpaid since 2013.
